

FORM FOR LODGING OF FIR/ COMPLAINT IN CASE OF THEFT ROBBERY/ DACOITY

Form to lodge/ complaint to police are now available with coach Attendants, Conductor, Guards, Railway Protection force [RPF] and train escorts in running trains in and with RPF posts/ out posts in important Railway stations. The effected passengers are requested to fill in the forms with relevant information and hand over to the above mentioned Railway officials RPF personnel. The same shall be promptly forwarded to the Government Railway Police(GRP) concerned for registration and further action. Passengers are not required to break their journey for lodging the report with the police.
